Synopsis Paducah Infrastructure Support Services Procurement

This notice is considered to be a synopsis in accordance with FAR Subpart 5.2 for the Paducah Infrastructure Support Services (Paducah ISS) procurement.

Within 15 to 60 days from the date that this notice is published, the U.S. Department of Energy (DOE) anticipates the issuance of a Request for Proposal (RFP), 89303324REM000130, for the Paducah ISS procurement. The new contract resulting from this acquisition will replace the current Paducah ISS Contract, DE-EM0003733.

The major elements of scope for this contract requires a contractor to provide infrastructure support services at the Paducah Site, to include but not limited to: Surveillance, Maintenance, and Repair and Construction/Replacement of Facilities; Custodial Services; Grounds Maintenance, Snow Removal, and Pest Control; Roadway Parking and Lot Maintenance; Fleet Management; Real Property Management; Records Management and Document Control; Safeguards and Security; Environment Safety, Health, and Quality Program; Engineering; Training Services; Mail Services; Waste Management, Pollution Prevention, and Other Activities and Support to DOE.

The Paducah ISS procurement will be conducted as a Total Small Business Set-Aside competition. The Government does not intend to acquire a commercial item or service using FAR Part 12. The North American Industry Classification System (NAICS) code for this requirement is 561210, Facilities Support Services, with a size standard is \$47.0 million.

The principal place of performance will be at the Paducah Site, a federal reservation located in western McCracken County, 10 miles west of Paducah, Kentucky and 3.5 miles south of the Ohio River, between U.S. Highway 60 and the Ohio River. The Paducah site encompasses approximately 3,556 acres with an additional 133 acres of off-site easements primarily associated with railroads, incoming raw water lines and pumps from the Ohio River, emergency notification sirens, and environmental sampling stations.
